Dear Families, Students, Teachers & Staff,

Welcome to Sts. Peter & Paul Catholic School. Your Cafe Food Program is provided by LaCaterers, Inc. La Caterers prepares meals and serves them daily on site in St. Ann's Hall. We offer a variety of choices daily, plus an A la Carte menu. This school year we are providing and publishing a new exclusive menu for Pre-K Classes. We will also continue to publish a monthly menu for Kinder through 8th grade with prices for you and your child to review. Below you will find a general list of helpful information about policy and procedures for the food program. Please talk with your children about the menu and procedures below.

Policy and Procedures

1. Students place their order every morning in their class room by 8 A.M.
2. Tardy students will let office know their lunch choice. Office will contact Food Service Department.
3. Pre-K students eat in their classrooms daily. K-8th grade eat in St. Ann's hall between 11 A.M.-12:30 P.M. You may ask your child's teacher for the actual time they are scheduled for lunch.
4. The majority of students charge meals onto their Facts Account. This keeps the line moving quickly! The advantage of Facts is you can go into your child's account and see what they purchase each day.
5. It is the parents responsibility to monitor their children's eating habits. Children charging their meals tend to think food in the cafe is free, because they are not using actual money. La Caterers will do everything possible to not allow children to over charge, but the responsibility will remain with the child's family. Please keep track of charges, because we will not remove any lunch charges after 10 days.
6. Through the Facts Program, we can put specific alerts on your child's account. Example: **Allergic to Peanuts** or My child can **only charge Milk, Juice or Bottled Water**. My child **can or cannot purchase ice cream or cookies**. To put a specific alert on an account, you can contact the school **Business Manager** or you can contact **Leslie Masters** at the Cafe or you can fill out the form at bottom of page for **Specific Alerts**.
7. You can always send a note with your child to the Cafe if you would like them to get a specific item.
8. Allergy Policy: Allergens are present in the cafe area and we cannot guarantee any items to be allergen free. We also cannot guarantee that ingredients we serve are received from "Nut Free Facilities".
9. Currently we are not serving any peanut items in the cafe. However it is possible that someone could bring a peanut item from home. The school offers a peanut free table in dining room, it is marked "**Peanut Free**".
10. Please provide the school with food allergy information. Below you may fill out the form for your child. Then cut out and turn into the School Office for further processing.
